RULES AND REGULATIONS FOR COLLEGE TRANSPORT

WHILE FILLING THE FORM I AM FULLY AWARE THAT

- The buses are operated on contract basis and the bus contractor decides the routes, timings and also takes predicted safety measures for the students traveling in the bus. The college is just acting as a catalyst / agent for the convenience of the parents and facilitating cost effective, and efficient service and it is stipulated and understood that the college (including its management and administration) shall not incur any liability, legal /financial or otherwise arising out of and in connection with providing such services and the students, their parents, guardians and legal assigns shall be deemed to accept and acknowledge this stipulation.
- The pickup point is based on the profile of the addresses where the child stays in the locality. The bus charges are decided according to the distance of the pickup point from the college and also may increase from time to time as and when there is a hike in the fuel charges, taxes, insurance etc are levied by the government on the bus contractors.
- The contractor is solely responsible for the safety of the children traveling in the bus only when the child is in the bus, and not after getting down either at college or at the opted bus stop (residence). Bus contractor will take utmost care of the students and will take all the necessary steps required for the safety of children traveling.
- Please note that college authority or the bus contractor is not responsible for any unforeseen circumstances or mishap if any occurs which is beyond their control.
- The college is providing this facility of contract college buses purely as a help and assistance to the students and undertakes no responsibility and liability for any loss or injury that may be sustained by a student or a parent arising out of availing such facilities. Responsibility or liability for any negligence or breach of duty in this connection shall exclusively rest with the Contractor, his driver(s), conductor(s) or attendant(s) and NOT with the college. The parents and students undertake and agree not to initiate or maintain any action against the college and hereby waive all rights and remedies in this behalf, against the College
